HOTEL LOCATION

The Hilton San Diego/Del Mar is a centrally located, resort-style hotel with easy access to most of San Diego's freeways. It is conveniently located near beautiful beaches, shopping, dining and the famous Del Mar Racetrack. San Diego International Airport is just 20 miles to the south, a quick 26-minute drive. The hotel offers a complimentary shuttle within a 5-mile radius of the hotel for guest convenience.

GUEST ROOMS

The spacious, renovated guest rooms offer a comfortable workspace for the business traveler and a tranquil environment for relaxation. Each of the 257 rooms is equipped with a complimentary high-speed Internet connection and a dedicated workstation. Each room provides natural lighting, windows that open and pool views. The rooms offer comfort, upscale amenities and versatile space. Each guest room includes a refrigerator.

From Orange County, take the I-5 South to Via de la Valle (Exit 36). Turn right on Via de la Valle and go 0.2 miles to Jimmy Durante Boulevard. Turn left. Hotel is on the left.

PET AGREEMENT

(This Agreement applies to domesticated pets other than Service Animals)

In consideration for the Hotel permitting me to keep my pet in the room assigned to me, I hereby agree to the following:

1. My pet is a domesticated dog or cat that weighs no more than 75 lbs.
2. No more than two pets are permitted in my guest room (see note below).
3. I agree to pay a \$35.00 nonrefundable service fee for my pet. I understand that additional fees may apply in the event my pet causes any damage. I further understand that additional fees will apply if I take the pet pillow, bowl and/or placemat.
4. I must keep my pet on a leash or in a pet carrier when my pet is outside my guest room.
5. My pet must NEVER be left unattended except if crated.
6. I must properly remove and dispose of any litter or waste associated with my pet on Hotel premises.
7. I understand that pets are not permitted in Hotel restaurants or other Hotel food and beverage areas or inside the gated pool area.
8. I understand that if my pet is in the guest room, my pet must be caged and I must be present while my room is serviced by anyone (i.e., housekeeper, engineer, room service, etc.).
9. I agree to pay the Hotel any charges for any necessary cleaning or repair due to pet stains and/or damage, as determined within the sole discretion of the Hotel. If I take the pet bed, bowl and/or placemat, I further agree to pay the Hotel any charges for such pet pillow, bowl and/or placemat, as determined within the sole discretion of the Hotel. I hereby authorize my credit card on record to be charged for the cost of these additional services and/or amenities.
10. I agree that I am responsible for the noise my pet creates and will ensure that my pet does not disrupt the quiet enjoyment of other hotel guests.
11. I agree that should the Hotel determine in its sole discretion that my pet is objectionable to other hotel guests, I must immediately make other arrangements to house the pet outside the Hotel.
12. I release the Hotel and Hilton Hotels Corporation, its parent, subsidiaries and affiliates (the "Hotel Entities") from any and all liability for any injury and/or damage suffered by my pet.
13. I agree that I assume full responsibility for any injury or damage caused or alleged to be caused by my pet and incurred or alleged to be incurred by any guest, employee or invitee of the Hotel. I agree to indemnify, defend and hold harmless the Hotel Entities from and against any and all alleged or actual losses, claims, damages, liabilities, costs and expenses (including attorneys' fees and court costs) suffered by the Hotel Entities or asserted by any other hotel guest, invitee employee or person arising out of or in connection with my pet's stay at the Hotel.
14. I understand and agree that the Hotel retains the right to exclude my pet if in the Hotel's sole discretion my pet is considered dangerous by reason of size, disposition or is likely to frighten or harm other guests of the Hotel.
15. I confirm that my pet has all required and up to date vaccinations and inoculations and does not have any communicable illnesses or diseases.
16. I agree that at all times while on Hotel property I will ensure my pet complies with all relevant laws and regulations of the state of California including any laws or regulations relating to the muzzling of my pet.

Notes:

1. For the 2017 VCA National Events, the Hilton has agreed to allow up to four dogs per room.
2. As a courtesy to fellow competitors, we ask that any bitches in season not be in the Del Mar Ballroom or vendors' foyer until after obedience and rally is complete on Tuesday. Bitches in season must wear pants while indoors.
3. As a courtesy to hotel guests, we ask that every male dog unable to refrain from urinating on anything handmade in the hotel common areas wear a bellyband.

- Rates include electricity, water (a pressure regulator is needed on water hookup), and one parking space.
- Surf & Turf RV Park does not have any amenities.
- Weekly and monthly rates include three sewer pumps per week. Pumps needed by daily renters must be paid at the time of or before pumping at a rate of \$20.00.
- Additional vehicle fees are \$5.00 daily, \$20.00 weekly, and \$40.00 monthly.
- Pets are welcome in the park. Dogs must be on a leash at all times. There is a pet fee of \$3.00 daily, \$10.00 weekly, and \$25.00 monthly.
- All units staying in the Surf & Turf RV Park must be 10 years old or younger.
