The Vizsla Club of America is offering Canine Good Citizen (CGC) testing & Trick Dog Title testing at the 2019 VCA Specialty



Tuesday April 30, 2019

Showcase your Vizsla's good behavior, use those tricks they know, or teach them a few new ones and they can earn one or more new AKC titles at the 2019 VCA Specialty!!

We will be conducting CGC tests and testing for the following Trick Dog titles: Novice, Intermediate, Advanced and Performer. *NOTE: We will NOT be evaluating Elite Performer titles.* Each dog may enter multiple levels/tests. If testing for CGC and using it as 5 of the Novice Tricks, CGC test **must** be passed before moving on to the Novice Tricks test.

Location: Obedience/Rally rings **Start Time:** ½ hour after the conclusion of the VCA Obedience/Rally Trial; not before 3pm

Pre-registration closes: April 20, 2019 **Pre-registration entry fee:** \$15 per test

On-site registration: if space permits, will be taken in the Hospitality area from 8am—12pm on April 30 **Fee:** \$20 per test

Testing fees above do not include AKC title application fees. Title applications must be submitted with a separate \$20 fee per title directly to AKC by owner.

There will be multiple evaluators at this event (Donna Nisleit, Diane Felicetta, Mary Hanneman & Ginger Sammonds). We will do our best to accommodate all who enter, but may have to limit entries to those tests that can be completed by the end of the event. All whose entries are confirmed received WILL be tested. A wait list will be maintained for any entries received over our limit.

Confirmation emails will be sent to those providing a legible email address. Running order will be emailed to all participants after the close of entries. *Refunds will **not** be issued after the close of entries except for injured dogs, with a confirming note from a veterinarian. Bitches in season **will** be allowed to participate, but may be moved to the end of the running order.*
