**ENTRY:** Entry fee is \$38.00 (Jr Handler \$19) for the first entry, \$28 (Jr Handler \$14) for the second and third entry, \$20.00 (Jr Handler \$10) for each additional entry of the same dog (includes AKC recording fee). Mail entries, maximum of 10 per envelope, with fees payable to **VCA** to

Express mail entries MUST waive the signature requirement or they will be refused. Exhibitors are responsible for complete, accurate, and legible information on their entry forms, and the correct entry fee. Checks returned due to non-sufficient funds will be assessed a \$30.00 fee. All illegible or incomplete forms or those with insufficient entry fees will be returned.

**CONFIRMATIONS:** Notification of entry status prior to closing will be emailed to all exhibitors providing an email address. Any exhibitor that does not have an email address should send a SASE or post card to be returned with their entry status information. No other acknowledgement of entry status will be given. Exhibitors with an email address are responsible for making sure their email address is legible and that any email from the trial secretary is not blocked by spam blockers or rejected due to a full mailbox.

Final entry confirmations and judging schedule will be sent after the final closing date to all exhibitors, as per Chapter 1, Section 19 of the regulations for Agility Trials. Exhibitors providing an email address will be emailed their confirmation. Exhibitors with no email address or whose email confirmations bounced will be sent their confirmations via USPS.

**DOGS ELIGIBLE TO ENTER:** This trial is open to all VIZSLAS 15 months of age or older that are registered with the American Kennel Club or that have obtained an AKC ILP or PAL listing number. Dogs with an ILP, PAL or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance, are not eligible to compete.

**MOVE-UP REGULATIONS:** Dogs may move up to a higher class at the request of the owner as a result of an agility title earned after closing; however, move-up requests must be made in writing and must be received by the Trial Secretary no later than Monday April 22, 2019 at 6:00 pm CST. They may be emailed to [entries@JPAWSAgility.com](mailto:entries@JPAWSAgility.com). Provide dog's call name, AKC number, owner's name, original class entered and new class requested. Dogs moved up will generally be placed at the end of the running order.

**COURSE WALK-THROUGHS AND WARM-UP INFORMATION:** Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. If necessary, the walk-through may be split at the discretion of the judges and trial committee. Obstacles shall meet the specifications for obstacles in the current edition of "Regulations for Agility Trials". A warm-up area consisting of a regulation jump will be provided for all exhibitors, who may not use the warm-up area to relieve their dog(s).

**MEASURING AND HEIGHT CARD INFORMATION:** Exhibitors are no longer required to submit a copy of their dog's jump height card with their entry or show it the day of the show at check in. It is the sole responsibility of the exhibitor to have their original, official jump height card or temporary jump height form at each trial to present upon request. If a measurement is necessary, it is the exhibitor's responsibility to have their dog measured prior to running.

**HEIGHT DIVISIONS:** Owners are responsible for entering the proper height divisions. Judges reserve the right to measure all dogs without a valid height card. Handlers may opt to run in a higher height division in the Regular program, but not in a lower division than their proper height division. Handlers must run in their proper height division in the Preferred program.

## NOTICE TO EXHIBITORS

Entry fees will not be refunded in the event that a dog is absent, excused, disqualified, or barred from the competition by action of the Trial Committee. No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

The trial giving Club assumes NO responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or any of their dogs or property and further assumes no responsibility for injury to children. Owners/handlers enter at their own risk and agree to assume responsibility for any damage caused by them, their dogs, or their children.

The Club reserves the right to remove any animal in distress from a parked vehicle or crate, and all persons attending this agility trial hereby waive any claim for damages against the Club for such removal.

Bitches that come into season will have their entry fee refunded less a \$12 administrative fee per day. Any dog sustaining an injury after the closing date may have their entry fee returned less a \$12 administrative fee per day. In both cases, the owner must provide the Trial Secretary with written notification at least 1 hour before judging begins.

Dogs are not required to be at the trial until the scheduled time of judging; however, handlers arriving after the scheduled course walk through for their class has taken place are not guaranteed a chance to walk the course. All dogs not needed for further judging are excused. The owner/handler is solely responsible for being ready at ringside when the class is to be judged.

All dogs must be on a leash no longer than 6' (flexi-leads must be kept under 6') at all times except when in the ring or when in the designated warm-up areas. Exhibitors and spectators are expected to keep the trial site clean. Please pick up after your dogs. Anyone witnessed not picking up after their dog will be excused from the trial weekend with no monies refunded.

Hotels and Campgrounds are an extension of the trial site and expectations are extended from the trial site to the hotels and campgrounds used by our exhibitors.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

## SITE INFORMATION:

The agility trial will be held at Canine Sports Zone (3036 Laura Ln, Middleton WI 53562). It will be indoors on professional-grade soccer turf in a climate controlled building. One ring measuring 130' x 80'. Snacks, lunch and refreshments will be provided for all attendees!

Ample crating space will be available. Please use mats underneath all crates. Dogs with space or barking issues should not be crated near the agility field. Crates may be left overnight; however, VCA and Canine Sports Zone will not be responsible for any lost or damaged items left at the show site. Dogs may NOT be left overnight.

There is also plenty of parking available in the parking lot around this facility, as well as street parking on Laura Lane.

**PLEASE PICK UP AFTER YOUR DOGS!** Potty your dog on the grass immediately around the Canine Sports Zone building or in the vacant lot across the street (Laura Ln). DO NOT allow your dogs to potty on the neighboring businesses grass or green space. Anyone caught not picking up after their dog(s) will be asked to leave without a refund.

**RIBBONS:** Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Rosettes will be awarded to the 1st through 4th place dog in each jump height in each class. T2B ribbons will be awarded for 10 pts, 9 pts and 8pts. Special QQ and QQQ key chains will be awarded as well, compliments of the Central Wisconsin Vizsla Club. Each dog and handler team that finishes an agility title will receive a New Title rosette. MACH and PACH rosettes and bars will also be awarded (donated by Katherine Hokens). Prizes must be claimed the day of the trial as none will be mailed.

**AWARDS:**

- High Master Agility: Copper Relief by Bev Capstick
- 1<sup>st</sup> Place (all classes/jump heights): Brass Wind Chimes
- 2<sup>nd</sup> through 4<sup>th</sup> Place (all classes/jump heights): Copper Mug

**HIGH MASTER AGILITY:** To be eligible for this award, a Master level dog must qualify in both Jumpers with Weaves (JWW) and Standard (STD) at the National Agility Trial. A tie will be decided by the fastest time in yards per second, averaging both rounds. If no Regular dogs QQ, the award will go to a Preferred dog with a QQ, with a tie being decided by the fastest time in yards per second, averaging both rounds. The winning dog will be showcased equally to the High Combined Obedience Dog and High Combined Rally Dog. A special award/trophy and rosette will be given to the High Master Agility Vizsla.

## DIRECTIONS:

**From the North / West:** Take US-12 toward Madison. Take the Airport Rd exit (Exit 250) toward Century Ave/County Hwy M. Turn left onto Airport Rd. Turn right onto Laura Ln. Continue to 3036 Laura Ln on the right.

**From the South / East:** Take US-12 (Beltline Highway) west. Take the Airport Rd exit (Exit 250) toward Century Ave/County Hwy M. Turn right onto Airport Rd. Turn right onto Laura Ln. Continue to 3036 Laura Ln on the right.

**From the Washington County Fair Park (Location of VCA National Events):** Head west on Pleasant Valley Rd, turn left to merge onto US 45 S. Exit at Hwy 60 (exit 63), stay to the right to head west on Hwy 60. Turn left onto WI-164S. Stay on WI-164S and merge onto I-94 West (right). Use the left lane to merge onto I-39S/I-90E (exit 240A). Use the right lane to merge onto US-12 (Beltline Highway) west (exit 142A) toward Madison. Take the Airport Rd exit (Exit 250) toward Century Ave/County Hwy M. Turn right onto Airport Rd. Turn right onto Laura Ln. Continue to 3036 Laura Ln on the right.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend, and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

**INSTRUCTIONS**

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners<sup>SM</sup> program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?

I CERTIFY that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above.
