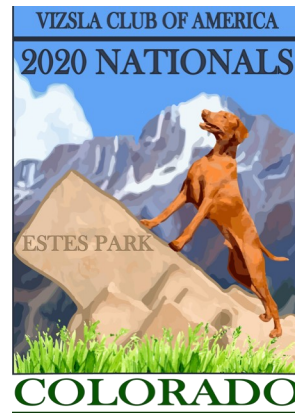

The Vizsla Club of America is offering Canine Good Citizen (CGC) testing & Trick Dog Title testing at the 2020 VCA Specialty

Monday August 24, 2020



**Showcase your dog's good behavior, use those tricks they already know,
or teach them a few new ones!**

We will be conducting CGC tests and testing for the ALL LEVELS of Trick Dog titles: Novice, Intermediate, Advanced, Performer and Elite Performer titles. Each dog may enter multiple levels/tests. If testing for CGC at this event and using it as 5 of the Novice Tricks, the CGC test must be passed before moving on to the Novice Tricks test.

Location: Obedience/Rally rings **Date:** Monday August 24, 2020 **Start Time:** After the Obedience/Rally Trial

Registration closes: August 17, 2020 **Entry fee:** \$15 per test (Pre-registration is required. No Day of Show entries.)

IMPORTANT NOTE: Testing fees above do not include AKC title application fees. To add the CGC or Tricks Titles to your dog's official record, title applications must be submitted with a separate \$20 fee per title directly to AKC by the dog's owner **after** tests have been passed. AKC Trick Title Application forms will be available at the event.

There will be multiple evaluators at this event. We will do our best to accommodate all who enter, but may have to limit entries to those tests that can be completed by the end of the event. All whose entries are confirmed WILL be tested. A wait list will be maintained for any entries received over our limit.

Confirmation emails will be sent to those providing a legible email address. Running order will be emailed to all participants after the close of entries. *Refunds will **not** be issued after the close of entries except for injured dogs, with a confirming note from a veterinarian.
Bitches in season **will** be allowed to participate, but may be moved to the end of the running order.*
